Events – Jerry Harkleroad, Chair

The North Bellevue Community Center is now reserved for the 2017 picnic on August 19<sup>th</sup>. We've placed a deposit of \$250. Plus \$380 for the caterer,

for a total expended of \$630. (Jordan I don't think we put a deposit down for the caterer, please check with Steve Denison on this)

The VFW hall is reserved for the 2017 Holiday party on December 8th. We have rolled over the \$500 deposit.

We can accommodate 125 people at each event. (I think this was a bit higher then 125, but don't recall the exact number, so please check with Steve) Strategic Planning Special Committee – Jim Cushing, & Jerry Bunce

A productive meeting was held Feb. 14 with Ben Meredith, the new Dean of Continuing Ed (BCCE) and Chris Ma. They expressed lots of support. The new Dean "gets it" and understands that Telos is an important part of BCCE and comprises an academic community.

The Dean is also enthusiastic about growth for TELOS. He's in full support of pursuing collaboration with CCEC. He wants to ask the Legislature to eliminate the geographical boundaries for TELOS, so we can operate and recruit area-wide.

The Dean further thinks we should expand to other Washington locations and that we could also go nationwide and seek grants.

A paid student intern is a possibility.

Dean Meredith will help advance our agenda with the Bellevue College Foundation. Telosians are not giving because of a lack in trust that the monies will be spent.

We are permitted to invite TELOS students to bring a friend to audit a class (One class per quarter, towards the end of each class, with instructor's permission a
