- a. Conclusions from the June 7, 2018, meeting with Al Lewis, Vice President, Workforce Development; Jennifer Sohonie, Director of Community Solutions; Edie Heppler, President, TSO Council; Chris Steele, Chair, TSO Curriculum Committee; and Jim Cushing, Chair, TSO Strategic Planning Committee are:
