Reports from Staff:

Liz Hollerman:: Dean of Business Technology and Continuing Education

- 1. The print schedule will occur no later than August 7
- 2. A welcome event/open house is being planned for September 12 and hopefully will refresh TELOS. The event will be held from 10 am to 12 m., and will be an introduction to TSO as a supplement to TELOS
- 3. Classes are open for registration
- 4. Lisa will report on the similar Edmonds model which has the same issues as TELOS: shorter classes, lower numbers with some classes not filling, and cancellations. Eight week courses are offered, but split into two parts—part I and part II, even though the hours and course content are almost the same, each segment is charged separately. Edmonds registration is 3 weeks prior to start of class while Bellevue College is 8 weeks before class start
- 5. Volunteer fundraising during registration can be accomplished through donation during class registration. While the College cannot process cash payments for classes, perhaps Student Programs could accept responsibility for monitoring the cash donations collected
- 6. The time needed for course proposal preparation needs to be extended
- 7. Enrollment services director, Brad Huggins will attend the August 23rd Meeting
- 8. Dr. May, the College's new President , values the student college experience. Dr. May is revising the administration so the Vice President for Student Affairs reports directly to the President and before the provost for Academic Affairs

Lisa Corcoran: Operations Manager

- a. Bette Murphy and Steve Denison met with Creative Retirement Institute Instructors who are hired as contractors for 4-week or shorter courses at Edmonds Community College. The goal was to learn how to operate a successful program
- b. Shorter 4-week classes could be tried during Winter/Spring
- c. Faculty contract possibilities have to go through bargaining. The faculty contract offers more inclusion in Continuing Educations. Separate contracts for each group of instructors who will have to be interviewed, course skills evaluated, and background checks accomplished
