- Minutes: The Minutes of May 22, 2019, were approved as submitted following a motion by Bryan Leyton and seconded by Tim Hay

Reports from Officers

President: Jerry Bunce

- 1. The Task Force on Tuition Increases met on June 6, 2019. Following a review of statistics presented by the administration representatives, the decision was made to accept the total average percentage increase in revenue as a measure of the increase in overhead costs. The average percentage increase in revenue is 6.9% which translates to an increase in tuition of \$6 per quarter for a total of \$85 per quarte for an 8-week, 1½-hour class. The motion to accept the recommendation was made by Jerry Bunce and seconded by Bryan Leyton. The recommendation passed, and will be effective when approved by Al Lewis.
- 2. The President also proposed an addition to the partnership statement in the catalogue: *TELOS provides a fulfilling experience for curious lifelong learners who want a broad range of classes in a learning environment. The TELOS Student Organization (TSO) partners with BC administration to create this robust learning community. The TSO curriculum committee collaborates with administration to identify instructors and intriguing course offerings.*
- 3. TSO website domain expires in August. The cost is \$20 per year. It was suggested that a three to five year website plan be developed which would entail writing and submitting a project plan. Tim Hay moved with a second by Bryan Leyton to approve the expense. The motion was approved.

Vice President: Tim Hay

The present BC plan to expand seating to accommodate large groups is to expand room 1120 by installing a sliding door to include the adjoining room 1118. TELOS awaits construction.

Secretary: Alexa Munoz

Consequent to several discussions concerning the lack of volunteers to run for TSO offices and lack of voter turnout, an article, "The Narrowing of Civic Life" by Theda Skocpol, on the changes in volunteerism was submitted for review and discussion.

Treasurer: Ron Lebeiko

1. Balanced forwarded from July 2018 was \$18,662, and income from July 2018 to July 2019 was \$7,149 which equals a balance of \$25, 911.
